### **SPECIAL NOTE** : Please read this **SPECIAL NOTE** before filling the form

1. Membership period shall be from 1<sup>st</sup> April to 31<sup>st</sup> March (12 Months in subsequent year of joining)
2. A member joining the Scheme after 1<sup>st</sup> April will have to pay full amount of admission fee, prorata fees credit will be adjusted in next annual renewal fees.
3. No refund is admissible to any member who wants to discontinue his membership at anytime.
4. A discontinued member if he / she wants to join the Scheme again will be treated as a new member.
5. Continuous membership of Maharashtra State Branch I.M.A. for the entire period of the coverage by the scheme is Mandatory.
6. For all legal disputes between the member and scheme administration the jurisdiction shall be restricted to the courts at Nagpur only.
7. Members doing MTP must get their Nursing Home / Hospital registered with Government under the MTP act. Similarly members must get registered with all bodies mandatory by law like Nursing Home Registration act, PCNDT Act. etc. whenever applicable.
8. Speciality of practicing consultants will be considered as per MCI recognized qualifications of the members and speciality training / experience in the particular field.
9. For any grievances of the members IMAMS Presidents decision shall be binding on the members as per IMAMS rules.
10. Discontinuation / Renewal / Rejoining
  - a) Notice will be sent one month in advance to all members for renewal of membership. The members should become life member of IMA before the first renewal.
  - b) A member who does not pay the annual membership fee in advance before 31<sup>st</sup> March. (Before the expiry of the indemnity cover) shall be discontinued without any notice.
  - c) However, if a discontinued member wants to revive his membership within one month of the expiry of the indemnity cover, he / she shall pay annual membership fee only, but the indemnity cover shall be provided from the day of revival of the membership.
  - d) After one month, if a member wants to rejoin the Scheme, he / she shall be treated as a new member and he / she shall have to pay admission fees as well as annual membership fees.
